

## **LEIAA BY AUGMETEC DEMO (LEGALTECHTALK PROMOTION) PRIZE DRAW (the "Prize Draw")**

### **TERMS**

These Terms (these "Terms") govern the relationship between you, the entrant ("you", "your(s)", "Entrant(s)") and Augmetec Limited of 71-75 Shelton Street, London, WC2H 9JQ with company number 14244375 ("Promoter", "we", "our", "us") in relation to this Prize Draw.

### **ELIGIBILITY**

1. 2. You will be required to provide the full name, work email address and telephone number of the Representative and any other attendees and confirm whether you would like the Demo to take place at your offices or virtually. The Demo must be attended by the Representative and any other representatives of the Entrant. On completion of a booking for a Demo, you will automatically receive and entry into the Prize Draw ("**Entry**").

**9.** Entry to this Prize Draw is restricted to one (1) Entry per Entrant during the Entry Period. You can only book one (1) Demo.

**10.** Any Entries which do not meet these Terms will not be valid and will be automatically disqualified.

**11.** All Entries (excluding personal information) are deemed to be non-confidential, become our property and will not be returned.

**12.** Entries received outside the Entry Period will be ineligible for entry.

**13.** Illegible, incorrect and/or incomplete Entries will be void and will not be accepted or eligible to win the prize.

**14.** Any use by Entrants of identities other than their own and any attempt by an Entrant to obtain more than one (1) Entry by using multiple/different email addresses, and/or any other methods, will void all of that Entrant's Entries and that Entrant may be disqualified from this Prize Draw.
