

## AUGMETEC SIMULATOR (LEGALTECHTALK PROMOTION) COMPETITION (the "Competition")

### TERMS

These Terms (these "Terms") govern the relationship between you, the entrant ("you", "your(s)", "Entrant(s)") and Augmetec Limited of 71-75 Shelton Street, London, WC2H 9JQ with company number 14244375 ("Promoter", "we", "our", "us") in relation to this Competition.

Copies of these Terms are available online at [augmetec.com](https://www.augmetec.com) (the "Website") and in hardcopy at the Event (defined in rule 1 below).

### ELIGIBILITY

1. This Competition is only open to individuals aged at least eighteen (18) years old or over or the legal age of majority in their jurisdiction (whichever is greater) at the time of entry, who: (a) attend the Legal Tech Talk conference on 13 or 14 June 2024 at the Intercontinental. O2, Greenwich, London, UK (<https://www.legaltech-talk.com/>) ("Event"); (b) speak to a member of our team at the Event at the Augmetec Booth or at a pre-scheduled one-to-one meeting about our LEIAA product; and (c) have a valid and active email address.

2. By entering this Competition, you confirm that you have legal capacity to enter this Competition and you agree to be bound by these Terms (i.e. that you are of sufficient age and mental capacity and are entitled to be legally bound in contract) and by our decisions, which are final in all matters relating to these Terms, this Competition and the winners' selection.

3. The following are not eligible to enter this Competition: (a) employees of the Promoter, its parents, affiliates, direct and indirect subsidiaries, its prize suppliers, travel companies, agents, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfilment and marketing agencies, web site providers and web masters (collectively, the "Promotion Entities"); (b) immediate family members of such employees or of anyone with whom such employees are domiciled; (c) the independent observer of the winners' selection; and (d) consumers, individuals and any other person or organisation that does not meet the eligibility requirements detailed above. In these Terms, "immediate family" includes mother, father, brothers, sisters, sons, daughters, partner or spouse;

4. By entering this Competition, you confirm that you have legal capacity to enter this Competition and you agree to be bound by these Terms (i.e. that you are of sufficient age and mental capacity and are entitled to be legally bound in contract) and by our decisions, which are final in all matters relating to these Terms, this Competition and the winners' selection.

### ENTRY PERIOD

5. This Competition starts at **08:00 British Summer Time ("BST") on 13 June 2024 and closes at 16:00 BST on 14 June 2024 ("Entry Period")**, comprised of two entry windows as follows (each an "Entry Day"):

### HOW TO ENTER

6. To enter this Competition, you must do the following on one of the Entry Days during the Entry Period:

- a. visit the Augmetec stand at the Event;

b. complete the entry form at the Augmetec stand, providing your name, phone number and email address as appropriate;

c. accept the terms and conditions of the simulator skill; and

d. set a lap time on the F1 simulator at the Augmetec stand ("**Lap Time**"). The fastest lap out of three laps will be taken (after a discretionary number of trial or practice laps are provided). The fastest lap will be recorded by a member of Augmetec staff on a spreadsheet of entrants, will confirm that the time recorded is accurate, and shall (at its sole discretion) display such time on a leaderboard at the Event. Limit one (1) attempt per Entrant,

(each an "**Entry**").

7. Entry to this Competition is restricted to one (1) Entry per person during the Entry Period. Therefore, you cannot participate in both Entry Days.

8. Any Entries which do not meet these Terms will not be valid and will be automatically disqualified.

9. All Entries (excluding personal information) are deemed to be non-confidential, become our property and will not be returned.

10. Entries received outside the Entry Period will be ineligible for entry.

11. Illegible, incorrect and/or incomplete Entries will be void and will not be accepted or eligible to win the prize.

13. Any use by Entrants of identities other than their own and any attempt by an Entrant to obtain more than one (1) Entry by using multiple/different email addresses, and/or any other methods, will void all of that Entrant's Entries and that Entrant may be disqualified from this Competition. The winner may be required to show proof of being the authorised account holder and proof that they are authorised to act on behalf of the Entrant. We also reserve the right in our sole and reasonable discretion to disqualify any Entrant who: (a) we have reason to believe has breached any of these Terms; and/or (b) corrupts or affects the administration, security, fairness, integrity or proper conduct of this Competition; and/or (c) engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of this Competition. Our legal rights to recover damages or other compensation from such an offender are reserved.

## **PRIZE**

14. There are a total of three (3) prizes comprising of: 1) a First Place Prize of a Silverstone Formula Single Seater Experience; 2) a Second Place Prize of an official Formula 1 Team cap of the winner's choice (or a similar prize of equivalent value); and 3) a Third Place Prize of an Augmetec branded Regatta Gilet, size of which will be provided accordingly to the winner.

15. A prize may only be redeemed by the winner. The winner may be required to present personal identification documents to prove their identity and will be responsible for paying any taxes in connection with the prize.

16. All prizes are subject to the terms and conditions of the supplier, particularly the First Place Prize for which terms and conditions of entry are separately available at <https://www.silverstone.co.uk/drive/formula-single-seater-experience>.

17. All other expenses not expressly specified herein are the sole responsibility of the winner, including any travel to/from venues, food, accommodation, insurance, photography or any other extras not specifically provided herein.

18. If due to circumstances beyond our control we are unable to provide the stated prize(s), we reserve the right to award a substitute prize(s) of equal or greater value.

**19.** We accept no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by the winner due to of entering the Competition or accepting the prize.

**20.** The prize must be accepted as awarded and is strictly non-transferable and non-refundable, and no cash alternative, exchanges or other substitute will be given. The prize cannot be combined with any other offer, promotion or discount.

#### **WINNER'S SELECTION**

**21.** The winners' selection will take place at the Promoter's stand at the end of the Entry Period. There will be a total of three (3) winners, who will be the three Entrants with the fastest Lap Times during the Entry Period from all valid and eligible Entries received during the Entry Period. The winners will be identified in the presence of an independent observer.

**22.** In the event that there are one or more tied Entries for the prizes, the winner will be the tied Entrant with the fastest 1<sup>st</sup> sector time. If the Entrants remain tied, the winner will be the tied Entrant with the fastest 2<sup>nd</sup> sector time. If the Entrants remain tied, the winner will be the tied Entrant with the fastest 3<sup>rd</sup> sector time. If this is not available, the winner will be selected by the toss of a coin, with the losing entrant gaining the next place.

**23.** The winners will be notified via the supplied email address within five (5) days of the winner's selection ("**Notification**"). The winner must confirm their acceptance of the prize by responding to the Notification by return email by no later than 17:00 British Summer Time (BST) on Friday 21 June 2024, including contact details of the winners (full name, email address, postal address and contact numbers).

**24.** In the event that:

(a) the winner cannot be contacted after two (2) attempts within three (3) business days of the winner's selection; and/or

(b) the winner does not respond by confirming its acceptance of the prize in accordance with rule 26;

(c) we have reasonable grounds for believing that a winner has contravened any of these Terms; and/or

(d) a winner is unable to accept the prize,

the winner forfeits the prize and we reserve the right to choose an alternative winner with the next fastest Lap Time.

**26.** The Promoter will use the personal data that it collects in connection with this Competition as set out in its privacy notice available at [augmetec.com](http://augmetec.com). We will use your personal information for the purposes of your entry into this Competition, in order to conduct and administer this Competition and to inform Entrants, upon request, of the winners' details (in accordance with rule 27) and fulfilling prizes.

**27.** If we do not collect your personal information, you will not be able to submit a valid Entry into this Competition or claim your prize. We may disclose this personal information to third parties for the sole purpose of processing and conducting this Competition.
